A RESOLUTION AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE PURSUANT TO QUEZON CITY ORDINANCE NO. NC-223, S-1991, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE BEREAVED FAMILY OF THE LATE SANGGUNIANG KABATAAN KAGAWAD MICHAEL D. AQUINO OF BARANGAY PAYATAS, QUEZON CITY, WHO WAS HACKED TO DEATH BY AN UNIDENTIFIED PERSON WHILE TRYING TO PROTECT THE LIVES OF INNOCENT PEOPLE DURING AN ALTERCATION ON FEBRUARY 28, 1993.

WHEREAS, the late Michael D. Aquino was duly elected as Sangguniang Kabataan Kagawad of Barangay Payatas, District II, Quezon City on December 4, 1992 Sangguniang Kabataan Elections;

WHEREAS, the deceased during his lifetime had been actively involved in community services for the youth like sports, maintenance of peace and order, anti-drug abuse campaign and spiritual upliftment which the youth of Barangay Payatas not only endeared so much but emulate too well;

WHEREAS, the deceased responded to the call of duty of protecting innocent lives during an altercation at Barangay Payatas whereby he shielded himself, so that a bolo wielding man could not inflict harm to the people inside a neighbor's house;


WHEREAS, his gallant efforts to perform his sworn duty to protect and serve his constituents resulted to his untimely death;

WHEREAS, such an act of gallantry of SK Kagawad MICHAEL B. AQUINO, not only of being commendable, should set as an example to the Quezon City youth;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the grant of financial assistance pursuant to Quezon City Ordinance No. NC-223, S-91, in the amount of Thirty Thousand Pesos (P30,000.00) to the bereaved family of the late Sangguniang Kabataan Kagawad Michael D. Aquino of Barangay Payatas, Quezon City who was hacked to death by an unidentified person while trying to protect the lives of innocent people during an altercation on February 28, 1993.
