RESOLUTION NO. SP- 981-98

A RESOLUTION EXPRESSING THE CITY COUNCIL'S RESOUNDING AND HEARTFELT CONGRATULATIONS, WELL WISHES AND ABIDING FAITH ON THE LEADERSHIP OF THE HONORABLE CONNIE S. ANGELES, VICE MAYOR AND PRESIDING OFFICER OF THE QUEZON CITY COUNCIL.

WHEREAS, Hon. Connie S. Angeles received her secondary education from the Royal and Pontifical University of Santo Tomas and the Degree of Bachelor of Arts in Philosophy and Letters from the Premiere State University, the University of the Philippines in Diliman, Quezon City and is a proud member of the honor society, Sigma Delta Phi Sorority;

WHEREAS, Hon. Connie S. Angeles was elected City Councilor representing the Third District of Quezon City in 1992 and until her reelection in 1996, she received the highest number of votes among other members of the City Council and thus, making her the number one overall Councilor of the City for two consecutive terms;

WHEREAS, Hon. Connie S. Angeles had served Quezon City and the City Council in various capacities of responsibility and importance, such as: Assistant Minority Floor Leader, Chairperson of the City Council's Committees on Women and Family Affairs; on Trade Commerce and Industry; Vice Chairman of the Committees on Health; and Handicapped People, and eventually as President Pro-Tempore;

WHEREAS, the continued operation of the Quezon City Hall Yakap, a day care center program for children and nursing mothers, is largely credited to the untiring efforts of Hon. Connie S. Angeles;

WHEREAS, in recognition of her extensive exposure to and expertise in the field of child care and related social service programs and activities, she was given the rare opportunity to address the United Nations Children's Fund (UNICEF) on the Philippines' experience in the implementation of our day care, child rearing and nursing programs, focusing more specifically on Quezon City's Yakap Day Care and Arugaan Centers, in Bangkok, Kingdom of Thailand;

WHEREAS, her innumerable achievements and successes have aptly given her the distinction as "Champion and Fighter for the Cause of Women and Children."

WHEREAS, her vast experiences and incomparable performances as a legislator have since been a witness to the adoption and enactment of various socially relevant and uplifting legislations, and, accordingly, she was adjudged, for three consecutive years (1993-1995), "Most Outstanding Councilor" by the Quezon City Press Association;

WHEREAS, on October 18, 1996, she was installed in the Hall of Fame of Quezon City's "Most Outstanding Councilor" for having received the Manuel Luis Quezon Bantayog Awards for three consecutive years from 1993 to 1995 by the Quezon City Press Association and has, since the beginning of her public service career, received various awards, honors and citations in full recognition of her firm commitment to serving the greater number of people by other media groups and people's organizations;

WHEREAS, the Hon. Connie S. Angeles, a staunch supporter and advocate of "Kapwa Ko, Mahal Ko" for sixteen (16) years, has consistently shown her love, care and devotion for our less privileged masses earning her the distinction of Best Public Service Program Host for two (2) consecutive years;

WHEREAS, an avowed media practitioner and awarded Best Children's Show Host, her twelve (12) year old youth-oriented television program, Pen Pen De Sarapen, serves as her living and incontestable contribution to the formation of positive values among our youth, the leaders of the future;

WHEREAS, in spite of her numerous public and social commitments, Hon. Connie S. Angeles devotes her time, effort and resources as Board Member of the Philippine Foundation for the Rehabilitation of the Disabled, the Philippine Registry of Interpreters for the Deaf, and other professional and socio-civic organizations:
