A RESOLUTION CONFIRMING THE APPOINTMENT OF ATTY. JOSE M. PUHAWAN AS CITY LEGAL OFFICER OF QUEZON CITY.

WHEREAS, His Honor, Ismael A. Mathay, Jr., City Mayor of Quezon City, in his letter dated July 29, 1998, endorsed to Her Honor, Connie S. Angeles, City Vice Mayor and Presiding Officer, Quezon City Council and to the Honorable Members of this August Body, the appointment of Atty. Jose M. Puhawan as City Legal Officer of Quezon City, for prompt and favorable action;

WHEREAS, Section 454, paragraph (d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specifically provides, that:

"Unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang panlungsod members, subject to civil service law, rules and regulations;"

WHEREAS, Atty. Jose M. Puhawan prior to his appointment as City Legal Officer Of Quezon City was the acting head of the Public Assistance and Legal Aid Officer (PALAO), providing free legal assistance to the less fortunate and indigent litigants who were constituents of this City, thus his appointment to the highest position of the City Legal Office of Quezon City is just appropriate and timely;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to confirm, as it does hereby confirm, the appointment of Atty. Jose M. Puhawan as City Legal Officer of Quezon City.
