RESOLUTION NO. SP- 9 9 3 4, 8-98

A RESOLUTION ACCREDITING THE CITY SECRETARY'S EMPLOYEES MULTI-PURPOSE COOPERATIVE WITH REGISTRATION NO. N-622-2020 ISSUED BY THE COOPERATIVE DEVELOPMENT AUTHORITY ON JULY 1, 1998, AND AUTHORIZING THE SAME TO OPERATE IN THEIR OFFICE AND SUCH OTHER PLACE DESIGNATED FOR THE PURPOSE.

WHEREAS, it is a declared policy of the State to promote the viability and growth of cooperatives as an instrument of equity, social justice and economic development;

WHEREAS, Article 2 of Republic Act No. 6938 otherwise known as the Cooperative Code of the Philippines providing, inter alia, that it is "the policy of the State to foster the creation and growth of cooperatives as a practical vehicle for promoting self-reliance and harnessing people power towards the attainment of economic development and social justice;"

WHEREAS, the employees of the Office of the Secretary to the Sanggunian Panlungsod have pooled together efforts and money to form a cooperative to augment their meager from salary as well as address their problem in their snacks;

WHEREAS, such cooperatives will even strengthen the employees cooperation and unity, and thus increasing their morale and identity as a part of the Office of the Secretary to the Sanggunian Panlungsod;

WHEREAS, such employees' development of favorable attitude and identity would increase their productivity in the performance of their respective responsibilities as public servants;

WHEREAS, to legitimize and be protected under the mantle of law, the City Secretary's employees have registered the City Secretary's Multi-Purpose Cooperative with the Cooperative Development Authority pursuant to R.A. 6938;

WHEREAS, the abovementioned cooperative was issued a Certificate of Registration numbered N-622-2020 dated July 1, 1998;

WHEREAS, the operation of said cooperative will be beneficial to the employees of said office as well as those personnel of the City Council;

WHEREAS, cooperatives are within the definition of people's organization;

WHEREAS, the local government units are mandated to promote the establishment and operation of people's and non-governmental organization to become active partners in the pursuit of local autonomy pursuant to Sec. 34 of R.A. 7160;

WHEREAS, it is the policy of the state that all departments, branches subdivisions, and instrumentalities of the Government shall promote the formations of cooperatives under their respective programs by providing them with appropriate and suitable incentives;

WHEREAS, consistent with the abovementioned policy provided in R.A. 6938 and 6939 and considering that cooperatives are considered people's organizations, Sec. 36 of the Local Government Code of 1991 provides as follows:

"Sec. 36. Assistance to People's and Non-governmental Organization - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction."

WHEREAS, the Sangguniang Panlungsod has the power to accredit people's and non-governmental organizations pursuant to Sec. 108 of R.A. 7160;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to accredit, as it does hereby accredit, the City Secretary's Employees Multi-Purpose Cooperative with Registration No. 622-2020 issued by the Cooperative Development Authority on July 1, 1998.

RESOLVED, FURTHER, to authorize, as it does hereby authorize, the said cooperative to operate and allow the same to bring in commodities; Provided, that the operations thereof will not in any way prejudice the performance of the function of the Office of the Secretary to the Sangguniang Panlungsod.
