BELMONTE, TO SIGN THE DEED OF DONATION OF THE EIGHT (8) AIR CONDITIONER UNITS TO BE DONATED IN FAVOR OF SELECTED HEALTH CENTERS, YAKAP DAY CARE CENTERS AND LOCAL GOVERNMENT OFFICES IN DISTRICT IV, QUEZON CITY AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO THE RECIPIENTS WITHOUT COST

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Section 16 or the General Welfare Clause of the same Code provides that every local government unit within their respective territorial jurisdictions is empowered, among others, to maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, in fulfilling the mandate of the said Code, eight (8) air conditioner units, to be distributed without cost to selected Health Centers, Yakap Day Care Centers, and Local Government Offices in District IV, Quezon City, were purchased from the available funds of the Quezon City Government;



WHEREAS, these donated air conditioner units will be installed in the respective offices of the recipients and will be utilized in the delivery of public service to the people of Quezon City; accordingly, it is proper to transfer the ownership and maintenance of the same to the said recipients through a Deed of Donation to be entered into by and between the respective representatives of the recipients and the Quezon City Government, represented by the City Mayor Honorable Ma. Josefina G. Belmonte.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign the Deed of Donation of the eight (8) air conditioner units to be donated in favor of selected Health Centers, Yakap Day Care Centers and Local Government Offices in District IV, this City, and authorizing the transfer of ownership of the same to the recipients without cost.
