A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SIGN THE DEEDS OF DONATION INVOLVING TWO HUNDRED THIRTY-SEVEN (237) BICYCLES WITH HELMETS, SIXTY (60) MOBILE FOOD CARTS WITH BICYCLES, EIGHTY (80) AMBULANT VENDOR CARTS WITH BICYCLES, ONE HUNDRED FIFTY-NINE (159) COLLAPSIBLE TENTS, ONE HUNDRED SEVENTY (170) MODULAR TENTS AND TWO HUNDRED FIFTY (250) QUAD CANES TO BE DONATED IN FAVOR OF BENEFICIARIES RESIDING IN DISTRICT IV, QUEZON CITY

WHEREAS, pursuant to Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, every local government unit within their respective territorial jurisdictions is empowered, among others, to enhance economic prosperity and social justice, promote full employment among their residents, and preserve the comfort and convenience of their inhabitants;

WHEREAS, in performing this mandate, 237 bicycles with helmets, 60 mobile food carts with bicycles, and 80 ambulant vendor carts with bicycles, purchased using the available funds of the Quezon City Government, will be distributed without cost to various recipients residing in various barangays in District IV of Quezon City;

WHEREAS, these non-motorized vehicles to be given to the recipients will be utilized for their livelihood activities, hence the need to transfer the ownership and maintenance thereof through Deeds of Donation to be entered into by and between the respective recipients and the Quezon City Government, represented by Quezon City Mayor Honorable Ma. Josefina G. Belmonte;

WHEREAS, in line with the same Section 16 of the Local Government Code of 1991, 159 collapsible tents and 170 modular tents procured through the available funds of the Quezon City Government shall also be given without cost to selected barangays, barangay officials, organizations, and individuals in District IV of this City;

WHEREAS, these acquired tents will be utilized for public events and activities and as temporary shelters of affected families during calamities and disasters; consequently, it is proper to transfer the ownership and maintenance of these properties to the respective recipients through Deeds of Donation to be entered into between them and the Quezon City Government, represented by our City Mayor Honorable Ma. Josefina G. Belmonte;

WHEREAS, pursuant to Section 17 of the same Code, local government units are empowered to provide basic health services and facilities such as medical equipment; thus, 250 quad canes bought using the available funds of the Quezon City Government shall likewise be distributed without cost to resident senior citizens and persons unable to walk properly residing in District IV of this City;

WHEREAS, to properly transfer the ownership of these quad canes, Deeds of Donation must be entered into by and between the respective recipients and the Quezon City Government, represented by the City Mayor Honorable Ma. Josefina G. Belmonte;

WHEREAS, Section 455(b)(1)(vi) of the Local Government Code of 1991, states that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign the Deeds of Donation involving two hundred thirty-seven (237) bicycles with helmets, sixty (60) mobile food carts with bicycles, eighty (80) ambulant vendor carts with bicycles, one hundred fifty-nine (159) collapsible tents, one hundred seventy (170) modular tents and two hundred fifty (250) quad canes to be donated in favor of beneficiaries residing in District IV, Quezon City.
