WHEREAS, DG Spheroids Corporation, as represented by Mary Tracy De Guzman, is applying for a Certificate of Exception for the construction and operation of an As-Built: One (1)-Storey Industrial Building (Warehouse and Manufacture of Container/Bottles), covering a total floor area of six hundred fifty-five and 50/100 square meters (655.5 sqm.) located at Lot 11, Block 1, Sauyo Road, Manchester 2 Industrial Compound, Barangay Bagbag, District V, Quezon City, allowing Deviation from the Restrictions provided under Quezon City Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, the Sangguniang Barangay concerned and the residents nearby the place of business therein interpose no objection to the operation of the said business establishment;
