A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT AND THE WOMEN CRISIS CENTER FOR THE IMPLEMENTATION OF DOMESTIC VIOLENCE PROTECTION PROGRAM IN FOUR (4) PILOT AREAS, NAMELY, BARANGAYS STO. CRISTO, ROXAS, BATASAN HILLS AND WEST KAMIAS, QUEZON CITY AND ALLOCATING THE NECESSARY FUNDS THEREFOR.

WHEREAS, until recently, violence in the family is considered to be a private matter and has to be resolved within the family only;

WHEREAS, as a consequence, people tend to ignore violent acts committed against family members such as the wife and the children;

WHEREAS, increasing incidence of domestic violence has reached an alarming proportion inflicting victims, especially women, with more violent physical harm leading to loss of self-esteem, dignity and confidence;

WHEREAS, in support to the International Convention as embodied in the Universal Declaration of Human Rights, U.N. Convention on the Elimination of All Forms of Discrimination Against Women and the Beijing Platform of Action, the City government should initiate a pilot project to implement relevant programs and services to eliminate such forms of domestic violence;



NOW, THEREFORE,


