A RESOLUTION RECOGNIZING QUEZON CITY AS THE "CITY OF STARS."

WHEREAS, most if not all of the major Television Studios, Movie Production Outfits and Recording Companies are in Quezon City, among which are the Sampaguita Pictures, FPJ Productions, LVN Studios, Regal Films, Viva Films, Seiko Films, Octoarts Films and Star Cinema and major television companies such as ABS-CBN-2 PTV-4, ABC 5, GMA 7, RPN 9 and IBC-13; major recording companies such as Vicor Music, Alpha Records, Octoarts, Viva Records, Star Records, Universal Records and BMG Records.

WHEREAS, the aforementioned establishments have produced most if not all of the locally and internationally renowned stars of Philippine entertainment and it is to the credit of Quezon City with its business-friendly attitude, that most, if not all of them are situated therein;

WHEREAS, it is but fitting and proper that Quezon City should lay claim to being the "City of the Stars" by virtue of the foregoing and should be proud of the fact that it is so;

WHEREAS, the recognition of Quezon City as the "City of Stars" would not only enhance the reputation of the city by way of its studios and celebrities present but further helps bring out and improve the Arts and Culture of Quezon City;

WHEREAS, the aim of this resolution is not only to recognize the Filipino Artist but also to boost the morale of our residents as well as those with hidden artistic talents and promote Quezon City not only locally but also internationally;

WHEREAS, upon the adoption of this resolution, the setting up of establishment honoring the "City of Stars" shall be encouraged such as but not limited to "Avenue of Stars and a "Museum" for arts and culture.


NOW, THEREFORE,
