RESOLUTION NO. SP-1019, S-98

A RESOLUTION AUTHORIZING THE ACQUISITION BY THE QUEZON CITY GOVERNMENT EITHER BY NEGOTIATED SALE OR THROUGH EXPROPRIATION OF A PORTION OF THE PROPERTY OF MR. ANTONIO A. ZUZUARREGUI, JR., WHICH IS BEING USED AS AN ACCESS ROAD KNOWN AS HIMLAYAN ROAD SERVING VARIOUS SUBDIVISIONS IN THE AREA, CONTAINING AN AREA OF ONE THOUSAND TWO HUNDRED FIFTEEN SQUARE METERS AND FIFTY FIVE DECIMETERS (1,215.55) DESCRIBED AS LOT 713-C-2 AND LOT 004-A-2-B UNDER TRANSFER CERTIFICATE OF TITLE NO. 66412 SITUATED IN BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, in a letter dated September 15, 1997, Mr. Antonio A. De Zuzuarregui, Jr., has manifested his willingness to negotiate for the acquisition by the City government, of his property (portion only) located at Barangay Pasong Tamo, Quezon city, which is now being used permanently as road lot by the Quezon City government, to wit:



WHEREAS, the acquisition by Quezon City of the said Road lot would provide convenient access to various subdivisions in the area and adjacent barangays;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the acquisition by the Quezon City government either by negotiated sale or through expropriation of the property of Mr. Antonio A. Zuzuarregui, Jr., which is being used as an access road known as Himlayan Road serving various subdivisions in the area, containing an area of One Thousand Two Hundred Fifteen Square Meters and Fifty Five Decimeters (1,215.55) described as lot 713-C-2 and lot 004-A-2-B under Transfer Certificate of Title No.66412, situated in Barangay Pasong Tamo, Quezon City.
