RE-CIRCULATION SCHEME THE APPROVING RESOLUTION CONCERNING THE ROUTE TO BE USED BY THE MEMBERS OF THE NG **PROJECT OPERATORS** AT DRIVERS "SAMAHANG P. TUAZON-FARMERS-CUBAO, INC." AS SPECIFIED IN THE BARANGAY RESOLUTIONS OF BARANGAYS SAN ROQUE, MASAGANA AND DIOQUINO ZOBEL, ALL OF PROJECT 4, DISTRICT III THIS CITY.

WHEREAS, the urgent need for transportation to serve commuters along Barangays San Roque, Masagana and Dioquino Zobel are clearly manisfested in the various resolutions of the subject Barangays;

WHEREAS, Barangay Dioquino Zobel passed Resolution No.20 on August 20, 1995 stating, among others, that the Samahang Operators at Drivers ng Project 4 P. Tuazon-Farmers-Cubao, Inc., be allowed to pass along Diego Silang, Fortune, M. Inocencio, L. Rivero and JP Rizal Streets;

WHEREAS, the Department of Land, Transportation and Communications (DOTC) ruling on the requests of the Barangays in its reply dated June 21, 1995, interposes no objection to the proposal and further said, "THE REQUEST DOES NOT NEED MODIFICATION OF THEIR FRANCHISE, BUT IT NEEDS ONLY APPROPRIATE MEASURES OF THE CITY COUNCIL TO ASSURE ITS EARLY IMPLEMENTATION;"



NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to approve, as it does hereby approve, the re-circulation scheme concerning the route to be used by the members of the "Samahang Operators at Drivers ng Project 4 P.Tuazon-Farmers-Cubao, Inc." as specified in the Barangay Resolutions of Barangays San Roque, Masagana and Dioquino Zobel, all of Project 4, District III this City.
