RESOLUTION NO. ~~SP-1028~~, S-98

A RESOLUTION AMENDING RESOLUTION NO. SP-501, S-95, AS AMENDED BY RESOLUTION NO. SP-982, S-98, OTHERWISE KNOWN AS THE RULES OF PROCEDURE OF THE 1998 SANGGUNIANG PANLUNGSOD.

WHEREAS, Section 50 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991 expressly provides, that:

"Section 50. Internal Rules of Procedure. - (a) On the first regular session following the election of each members and within (90) days thereafter, the Sangguniang concerned shall adopt or update its existing rules of procedure;"

WHEREAS, the current Rules of Procedure adopted by the City Council do not provide for any provision directing the Secretary to the Sangguniang Panlungsod to inform and notify the proponent or introducer of a certain measure that a particular resolution or ordinance containing a similar subject matter had been filed earlier or ahead and the same is under consideration of the City Council, to avoid confusion, chaos and misunderstanding during deliberations.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-501, S-95, as amended by Resolution No. SP-982, S-98, otherwise known as the "Rules of Procedure of 1998 Sangguniang Panlungsod of Quezon City, by amending Section 7 thereof which shall read, as follows:




- i. The Secretary to the Sangguniang Panlungsod shall notify and inform the introducer or proponent of a certain measure that a particular resolution or ordinance containing a similar subject matter had been filed earlier or ahead and the same is under consideration of the City Council before it is received, docketed and included in the Agenda for First Reading.
