## RESOLUTION NO. SP- 1029, S-98

A RESOLUTION STRONGLY URGING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO MAKE REPRESENTATIONS WITH THE BUREAU OF FIRE PROTECTION FOR THE ESTABLISHMENT AND MAINTENANCE OF A FIRE STATION WITHIN THE QUEZON CITY HALL COMPOUND.

WHEREAS, hostile fire spares no one and that it strikes anytime where it is least expected inspite of preventive measures being undertaken/adopted by private and government offices;

WHEREAS, the Quezon City government have several times had horrible experiences of conflagration that destroyed not only a big portion of the Quezon City Hall offices, but also damaged vital and important documents such as Court records, land titles and office machines and equipments, including that which happened last August 7, 1998, when the 5th floor of the City Hall was razed by fire;

WHEREAS, the establishment and maintenance of a fire station within the Quezon City Hall compound is necessary which should be made one of the components in every provincial, city and municipal hall where accessibility to fire protection and immediate rescue and relief operations is made available to avert the occurrence of big fire and/or at least minimize the losses and damages arising therefrom;

WHEREAS, almost every city or municipality in the Metropolitan Manila area maintains a fire station within its compound;

WHEREAS, the Quezon City government is willing and ready to accommodate, support and provide an area or space for the establishment and maintenance of the fire station;
