RESOLUTION NO. SP-10312, 8-98

A RESOLUTION STRONGLY URGING ALL THE BARANGAY KAGAWADS OF QUEZON CITY TO ORGANIZE AND FORM ONE CITY-WIDE ASSOCIATION, LEAGUE OR FEDERATION OF BARANGAY KAGAWADS

WHEREAS, at present, there are an estimated 987 incumbent barangay officials elected to the position of kagawad in the 142 barangays comprising the four districts of Quezon City;

WHEREAS, those occupying the position of barangay kagawads are among the local government officials who presently do not have a nation-or city-wide league or association of their own formally registered with and recognized by the appropriate government agencies;

WHEREAS, an organized body of those elected as barangay kagawads is necessary and desirable for an efficient and effective government;

WHEREAS, Republic Act No. 7160, entitled "AN ACT PROVIDING FOR A LOCAL GOVERNMENT CODE OF 1991" provides that:

(a) Vice governors, vice mayors, <u>sangguniang members of barangays</u>, municipalities, component cities, highly urbanized cities and provinces, and other elective officials of local government units, including those of the Metropolitan Manila area and any metropolitan political subdivisions, <u>may form their respective leagues or federations</u> subject to applicable provisions of this title and pertinent provisions of this Code;
