A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TOTAL PETROLEUM PHILIPPINES CORPORATION FOR THE CONSTRUCTION OF A GASOLINE SERVICE STATION ALONG QUIRINO AVENUE, BARANGAY PASONG PUTIK, QUEZON CITY.

WHEREAS, petitioner, Total Petroleum Philippines Corporation has requested the Quezon City Council through the Office of the Majority Floor Leader for the issuance of a special use permit for the construction of a gasoline service station at Quirino Avenue, Barangay Pasong Putik, Quezon City;

WHEREAS, the construction and establishment of a gasoline station along Quirino Avenue, Barangay Pasong Putik, Quezon City is beneficial to the general public and that the area identified or the proposed site conforms with the list of permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992" and its Implementing Rules and Regulations (IRR) through appropriate measure passed by the Quezon City Council authorizing the construction thereof at the area hereunder specifically designated, to wit :


