A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ISMAEL A. MATHAY, JR., TO DISPOSE OF THE PARCEL OF LAND OWNED BY THE QUEZON CITY GOVERNMENT (PESIGAN PROPERTY) IDENTIFIED AS LOT 113-D-4-D, PSD-9900, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 25827 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONSISTING OF TWENTY THOUSAND SQUARE METERS AND LOCATED AT GROUP 13, PAYATAS-B, QUEZON CITY, TO BE AWARDED TO THE QUALIFIED TENANTS/OCCUPANTS THEREIN THRU THE FORMULATION OF THE "LOT ONLY" PROGRAM AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE.

WHEREAS, the Quezon City government is the owner of a parcel of land situated in Barangay Payatas, known as Pesigan Property, identified as Lot 113-D-4, Psd-9900, consisting of Twenty Thouand (20,000), square meters and covered by Transfer Certificate of Title No. 25827;

WHEREAS, the qualified families/tenants thereat are now petitioning the City government to allow them to acquire the land thru the formulation of a "Lot Only" Program;

WHEREAS, the occupants of the above described property organized themselves known as SAMAHAN NG NAGKAKAISANG DAMDAMIN, ISIP AT GAWA (SANDIG, INC.)

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Hon. Ismael A. Mathay, Jr., to dispose of the parcel of land owned by the Quezon City government (Pesigan Property) identified as lot 113-D-4-D, Property-9900, covered by Transfer Certificate of Title No. 25827 of the Registry of Deeds of Quezon City, consisting of Twenty Thousand (20,00) square meters and located at Group 13, Payatas-B, Quezon City, to be awarded to the qualified tenants/occupants thereof thru the formulation of the "Lot Only" program at a price to be determined by the City Appraisal Committee.
