A RESOLUTION AMENDING RULE II, SECTIONS 4 AND 5 OF RESOLUTION NO. SP-501, S-95, AS AMENDED BY RESOLUTION NO. SP-982, S-98, OTHERWISE KNOWN AS THE RULES OF PROCEDURE OF THE QUEZON CITY COUNCIL.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to amend, as it does hereby amend Rule II, Sections 4 and 5 of Resolution No. SP-501, S-95, as amended by Resolution No. SP-982, S-98 so as to add in Rule II, Section 4 the herein provision as paragraph 3.

"Sec. 4. The composition of members of the City Council as to majority or minority affiliations shall be made by the conduct of open declaration of each individual member in open session prior to any election of the Council's Internal Government."

RESOLVED, FURTHER, that the provisions in Rule II, Section 5, shall read as follows:

"Sec. 5. Term of Office - The Chairman and the Members of the Regular Committees, except the Presiding Officer, shall serve for one (1) year unless sooner removed by a 2/3 vote of all members of the Council. The officers of the Council shall serve for one (1) year, unless sooner removed by 2/3 vote of members of the corresponding majority or minority group pertaining to the officers' position."
