RESOLUTION NO. SP 1048, S-98

A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE OFFICE OF THE CITY COUNCIL, REPRESENTED BY THE CITY VICE MAYOR OF QUEZON CITY AND GECYCON BUILDERS AND CONSTRUCTION, REPRESENTED BY THE GENERAL MANAGER, MRS. CONCEPCION CABACABA, FOR THE IMPLEMENTATION OF THE IDENTIFIED COMMUNITY-BASED PROJECTS AT VARIOUS LOCATIONS IN QUEZON CITY.

3. Installation of Park Lamp Post along Barangay Apolonio Samson Q.C.	P152,328.00

WHEREAS, the power vested upon the City Vice Mayor to enter into negotiated contract and sign the same in behalf of the Quezon City government would hasten the delivery of services to the public;

WHEREAS, the above-mentioned projects redounded to the benefit of the residents living thereat and are now being enjoyed by the constituents and the general public having been completed and delivered by the contractor,
