A RESOLUTION AUTHORIZING THE QUEZON CITY GENERAL HOSPITAL, QCGH - STA. LUCIA ANNEX HOSPITAL AND QCGH-NOVALICHES ANNEX HOSPITAL TO DEPOSIT ITS REVENUES DERIVED FROM MEDICARE FEES, DONATIONS AND OTHER HOSPITAL FEES TO A GOVERNMENT DEPOSITORY BANK AND TO TRANSFER ITS EXISTING TIME DEPOSITS FROM THE PHILIPPINE NATIONAL BANK TO LAND BANK OF THE PHILIPPINES, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Quezon City General Hospital's other sources of revenues are from the Medicare claims, donations and other hospital fees;

WHEREAS, Sec. 65, Article XTV-A of R.A. 6548, otherwise known as the revised City Charter of Quezon City, requires that all the money arising from income and revenues of the hospital shall, with the approval of the City Council, be deposited in a government depository;

WHEREAS, the present policy of the government is to prioritize the Land Bank of the Philippines as the depository bank of government;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City General Hospital, QCGH - Sta. Lucia Annex Hospital and QCGH-Novaliches Annex Hospital to deposit its revenues derived from medicare fees, donations and other hospital fees to a government depository bank and to transfer its existing time deposits from the Philippine National Bank to Land Bank of the Philippines, subject to existing laws, rules and regulations.
