RESOLUTION NO. SP-1065-98

A RESOLUTION STRONGLY URGING THE OFFICE OF THE CITY MAYOR TO CREATE A PROTOCOL SECTION WITHIN THE CULTURAL AND TOURISM AFFAIRS OFFICE TO HANDLE ALL OFFICIAL ACTIVITIES OF THE QUEZON CITY GOVERNMENT.

WHEREAS, dignitaries, government officials, visitors and guests, prospective investors and well known personalities from other countries who wish to visit and come to Quezon City, either for business or tourism and/or charity purposes would like to know whom to communicate, arrange, negotiate and handle their official visit to the Quezon City government and how to pay courtesy call with the City officials running the affairs of the local government unit, and, moreover, to ensure their safety during their visit as they are security and protocol conscious;

WHEREAS, all local government units, particularly Quezon City which is the premier City of the Philippines, have to appoint a Protocol Officer who knows the ins and outs of the city including the plans and programs of the Quezon City government who will handle all official activities of the government, official visits of foreign dignitaries, business executives, visitors and guests of the city;

WHEREAS, there are government officials and businessmen who are protocol conscious and the appointment of the protocol officer is necessary as this is the official practice observed even by the national government and duly adopted by the foreign countries to make sure that these visitors are attended to with full courtesy and attention as the Philippines is internationally noted for being hospitable;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Office of the City Mayor to create a Protocol Section within the Cultural and Tourism Affairs Office to handle all official activities of the Quezon City government.
