A RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN MRS. JUANARIA HANULI-PEDRO, AS DONOR, AND QUEZON CITY REPRESENTED BY HIS HONOR MAYOR ISMAEL A. MATHAY, JR., AS DONEE, OVER A CERTAIN PARCEL OF LAND CONSTITUTING THE OPEN SPACE OF LOT 708-B-2-B OF THE SUBDIVISION PLAN (LRC) PSD-91231 PARTICULARLY IDENTIFIED AS LOT 1, BLOCK 1, WITH AN AREA OF TWO HUNDRED FORTY (240) SQUARE METERS LOCATED IN BARANGAY PASONG TAMO, QUEZON CITY, AND ENTERED IN THE NOTARIAL REGISTRY OF ATTY. DULCISIMO G. HINANAY, JR., IN DOC. NO. 182; PAGE NO. 37; BOOK NO. X; SERIES OF 1997.

WHEREAS, Mrs. Juanaria Hanuli-Pedro, owner of Lot 708-B-2-B of the subdivision plan (LRC) Psd-91231 located at Barangay Pasong Tamo, has executed a Deed of Donation in favor of Quezon City, over a certain parcel of land constituting the open space of the aforesaid subdivision;


WHEREAS, the office of the City Legal Officer in its 1st Indorsement dated October 27, 1998 recommended the acceptance of the said donation by Quezon City;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Deed of Donation entered into by and between Mrs. Juanaria Hanuli-Pedro, as donor, and Quezon City represented by His Honor, Mayor Ismael A. Mathay, Jr., as donee, over a certain parcel of land constituting the open space of Lot 708-B-2-B of the subdivision plan (LRC) Psd-91231 particularly identified as Lot 1, Block 1, with an area of Two Hundred Forty (240) square meters located in Barangay Pasong Tamo, Quezon City, and entered in the Notarial Registry of Atty. Dulcisimo G. Hinanay, Jr. as Donor.
