A RESOLUTION RATIFYING THE TEN (10) CONTRACTS MADE AND ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY HON. ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND GELIAN TRADING AND CONSTRUCTION, REPRESENTED BY ITS MANAGER, ELOISA A. SANTOS, AS THE SECOND PARTY, FOR THE INSTALLATION OF ARTESIAN WELLS IN BARANGAY PASONG TAMO, PASONG PUTIK, CLARO, GREATER LAGRO, SAN AGUSTIN, BAGBAG, SAN BARTOLOME, BAGONG SILANGAN AND CULIAT, QUEZON CITY IN THE AGGREGATE AMOUNT OF SIX HUNDRED FORTY-NINE THOUSAND THREE HUNDRED PESOS (P649,300.00), TO BE CHARGED AGAINST THE LINGAP FUNDS OF THE 1998 CITY BUDGET.
