A RESOLUTION URGING THE HONORABLE CITY COUNCIL TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE BRIGIDO A. VELASCO, PUNONG BARANGAY OF BARANGAY SAN JOSE, DISTRICT I, QUEZON CITY, THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS UNDER THE 1999 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.
