RESOLUTION NO. SP- -1-078- , S-1999

A RESOLUTION DIRECTING THE CITY GENERAL SERVICES OFFICER, THE DIVISION SUPERINTENDENT OF CITY SCHOOLS, THE CITY FIRE MARSHALL AND THE CITY ADMINISTRATOR TO SUBMIT A FULL ACCOUNT AND REPORT TO THE QUEZON CITY COUNCIL ON THE CAUSE BEHIND THE FIRE INCIDENT THAT DESTROYED THE FIFTH FLOOR OF THE QUEZON CITY HALL HOUSING THE DIVISION OF CITY SCHOOLS, IN AID OF LEGISLATION AND FOR OTHER PURPOSES.

WHEREAS, on 7 August 1998, on or about 7 o'clock in the evening, a fire struck the fifth floor of the multi-storey building of the Quezon City Hall;

WHEREAS, said fire incident reached the General Alarm Status as declared by the City Fire Marshall;

WHEREAS, the fire incident has caused invaluable and irreparable damage to documents, papers and properties of the City government;

WHEREAS, incident such as this, casts a doubt on the security and safety of the properties and employees working within the City Hall compound and its structures;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to direct, as it does hereby direct, the City General Services Officer, the Division Superintendent of City Schools, the City Fire Marshall and the City Administrator to submit a full account and report to the Quezon City Council on the cause behind the fire incident that destroyed the fifth floor of the Quezon City Hall housing the Division of City Schools, in aid of legislation and for other purposes.
