RESOLUTION NO. ~~SP-1087~~ SP-1087-99

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF THE AMOUNT OF SIX MILLION TWO HUNDRED NINETY FOUR THOUSAND THREE HUNDRED FIFTY PESOS AND FIFTY-FOUR CENTAVOS (P6,294,350.54) TAKEN FROM THE HOSPITAL DEVELOPMENT FUND USED BY THE QUEZON CITY GENERAL HOSPITAL IN 1995 FOR THE EMERGENCY PURCHASE OF MEDICINES, HOSPITAL SUPPLIES, INCLUDING THE REPAIR OF VITAL EQUIPMENT, WHICH WERE NECESSARY TO SAVE THE LIVES AND LIMBS OF THE INDIGENT PATIENTS OF SAID HOSPITAL.

WHEREAS, in 1995, the sum of P3,274,590.00 was transferred to the Quezon City General Hospital (QCGH) out of the approved budget for Maintenance and Other Operating Expenses (MOOE) of P15,818,627.00;

WHEREAS, there was a large increase in the admission of patients from 12,504 in 1989 to 18,576 in 1995, the cost of service for which amounted to P29M annually;

WHEREAS, the request of the QCGH at that time for authority to use the Hospital Development Fund for the maintenance and operation of the hospital was not acted upon by the Quezon City Council, as a consequence of which, the QCGH was forced to use P6,294,350.54 of the Hospital Development Fund for the emergency purchase of much needed medicines, hospital supplies, including the repair of vital hospital equipment, as a last resort to save lives and limbs of its indigent patients;

WHEREAS, the disbursement of said amount of P6,294,350.54 is the subject of a notice of suspension issued by the QCGH resident auditor;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED to authorize, as it does hereby authorize, the disbursement of the amount of Six Million Two Hundred Ninety Four Thousand Three Hundred Fifty Pesos and Fifty-Four Centavos (P6,294,350.54) taken from the Hospital Development Fund used by the Quezon City General Hospital in 1995 for the emergency purchase of medicines, hospital supplies, including the repair of vital equipment, which were necessary to save the lives and limbs of the indigent patients of said hospital.
