RESOLUTION NO. SP- 1095- 3-1999

A RESOLUTION RATIFYING THE LEASE CONTRACT ENTERED INTO BETWEEN THE QUEZON CITY GOVERNMENT AND THE LIONS CLUBS INTERNATIONAL DISTRICTS 301-D1 AND 301-D2 INVOLVING THAT PORTION OF BERNARDO PARK LOCATED AT EDSA, KAMUNING, QUEZON CITY.

WHEREAS, by virtue of Quezon City Council Resolution No. 9181, S-72, adopted on September 11, 1972, the Quezon City Council has authorized the allocation and lease of a Nine Hundred Fifty (950) square meter lot within the Bernardo Park compound as site of the headquarters of the Lions Club International District 301-D (now Districts 301-D and 301-D2), subject to specific terms and conditions as stipulated therein;

WHEREAS, the term of 25 years of the original contract is deemed expired as of October, 1997;

WHEREAS, the City Council, through Resolution No. SP-849, S-98, adopted on February 19, 1998, has authorized the Honorable Ismael A. Mathay, Jr., City Mayor, to enter into a contract of lease, as lessor over a portion of Bernardo Park with Lions Club International, as lessee.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Lease Contract entered into between the Quezon City government represented by Hon. Ismael A. Mathay, Jr., City Mayor, as lessor and Lion's Clubs International Districts 301-D1, and 301-D2, represented by District Governors Rolando R. Inovero and Heracillo F. Palad, as lessees involving that portion of Bernardo Park located at Edsa, Kamuning, Quezon City, consisting, more or less, of Nine Hundred Fifty (950) square meters for a period of Twenty-Five (25) years, which document was entered into the Notarial Book of Notary Public Romeo C. Cruz, under Doc. No. 6692, Page 23, Book No. CW Series of 1998.

RESOLVED, FURTHER, to withdraw from public use that portion of the city-owned Bernardo Park located at E. De Los Santos Avenue, Kamuning, Quezon City, consisting of Nine Hundred Fifty (950) square meters, more or less, presently occupied by Lion's Clubs International Districts 301-D1 and 301-D2.
