A RESOLUTION URGING THE HONORABLE ISMAEL A. MATHAY, JR, TO ALLOCATE THE AMOUNT OF FOUR HUNDRED SIXTY-SIX THOUSAND ONE HUNDRED THIRTY-NINE PESOS (P466,139.00) FROM THE COMMUNITY DEVELOPMENT FUND OF THE CITY, OR FROM ANY OTHER AVAILABLE FUND IN THE CITY TREASURY, FOR THE CONCRETING OF SIDEWALKS ALONG ERMIN GARCIA STREET.

WHEREAS, Ermin Garcia Street in Barangay Silangan is a major road artery utilized regularly by motorists as an alternative route to evade the traffic congestion at E. De Los Santos Avenue, aside from being a shorter route from the Cubao area to the northern portion of the City and vice-versa;

WHEREAS, Barangay Silangan, traversed by subject road, is a densely populated barangay and without defined pedestrian sidewalks, thus contributing to the heavy traffic thereat which places in danger the pedestrians therein;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable Ismael A. Mathay, Jr., to allocate the amount of Four Hundred Sixty-Six Thousand One Hundred Thirty-Nine Pesos (P466,139.00) from the Community Development Fund of the City, or from any other available fund in the City Treasury, for the concreting of sidewalks along Ermin Garcia Street.
