## RESOLUTION NO. SP: 1 10 07 S-99

A RESOLUTION URGING THE CITY MAYOR TO FACILITATE THE GRANT OF HEALTH INSURANCE COVERAGE BENEFITS TO THE DULY APPOINTED EXECUTIVE OFFICERS AND MEMBERS OF THE BARANGAY SECURITY AND DEVELOPMENT OFFICE (BSDO) IN EVERY BARANGAY IN QUEZON CITY.

WHEREAS, Section 387 (b) of Republic Act 7160, otherwise known as the 1991 Local Government Code, recognizes the creation of community brigades in every barangay when it stated:

" $x \times x$ . The sanggunian barangay may form community brigades and create such other positions or offices as may be deemed necessary to carry out the purposes of the barangay government.  $x \times x$ ".

WHEREAS, the Barangay Security and Development Officers (BSDO's) are members of such brigades and are considered as agents of persons in authority, as expressly provided in Sec. 388 of the code, a part of which reads:

"x x x other barangay officials and members who may be designated by law or ordinance and charged with the maintenance of public order, protection and security of life and property. x x x shall be deemed agents of persons in authority. . . x x x".

WHEREAS, it has been noticed and observed that members and executive officers of BSDO's have been consistently, religiously, regularly and efficiently performing their functions in maintaining peace and order, securing the life and limbs of their constituents; regulating traffic flows in their respective barangays, among other things, notwithstanding the weather condition and regardless of the time of the day and night;
