RESOLUTION NO. SP- 1103 - S-99

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE THIRTY-NINE (39) FAMILIES, WHOSE HOUSES WERE GUTTED DOWN BY FIRE AT 96 KALIRAYA STREET, BARANGAY TATALON, DISTRICT IV, QUEZON CITY, IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY SHARER/RENTER AND ALLOCATING THE SUM OF FIFTY THOUSAND PESOS (P50,000.00) TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, Section 455 (b) (1) (vii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that;

“Section 455. (b) For Efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:

- (1) Exercise general supervision and control over all programs, projects, services and activities of the city government and in this connection shall:
- (vii) Carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities”.

WHEREAS, Section 458 (a) (1) (iv) of the same Act, provides that:

“Section 458 (a) The sanggunian panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, shall:

- (1) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection, shall:

- (iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."

WHEREAS, on July 21, 1998, a fire struck at 96 Kaliraya Street, Barangay Tatalon, District IV, Quezon City, rendering thereat the thirty-nine (39) families homeless as per census by the Social Services Development Department (SSDD), to wit:

WHEREAS, because of this unfortunate incident, our constituents need the help and assistance of the City government in the form of financial aid for food, clothing and materials for the construction of their houses;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the thirty-nine (39) families, whose houses were gutted down by fire at 96 Kaliraya Street, Barangay Tatalon, District IV, Quezon City, in the amount of Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family sharer/renter and allocating the sum of Fifty Thousand Pesos (P50,000.00) to be taken from the calamity or emergency fund or from any available funds of the City.


RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate and authenticate the list of fire victims categorized into family owner, family sharer and family renter and to submit the same to the Office of the City Mayor and shall make representation with the Offices concerned for the early release of the financial assistance to the qualified recipients.

RESOLVED, FINALLY, that the Office of the City Mayor shall revalidate and confirm the list submitted by the Social Services Development Department which will be made the basis for the preparation of the payroll and to approve the immediate release of funds allocated for the purpose.
