RESOLUTION NO. SP- ~~1104~~ S-99

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR. TO ACQUIRE, THROUGH NEGOTIATION OR EXPROPRIATION, A SIX HUNDRED (600) SQUARE METER LOT LOCATED AT VILLA BEATRIZ, BARANGAY OLD BALARA, QUEZON CITY, FOR RESTORATION AS SITE OF A PUBLIC PARK AND BASKETBALL COURT.

WHEREAS, a six hundred-square meter lot at Villa Beatriz Street, under Transfer Certificate of Title Number 64514, which used to be the only playground and basketball court for the residents of Area 5, Barangay Old Balara, until a year ago when said lot was fenced in by its private owner, thus, depriving the residents of the use of the basketball court facilities they have put up from donations;

WHEREAS, the residents of the area composed of some four thousand (4,000) families have no other playground or park for their recreational, sports and other public activity needs;

WHEREAS, there is an urgent need to provide the residents, especially the youths with facilities for sports, athletics and other wholesome activities in order to deter the encroachment of harmful vices on their lives;

WHEREAS, the Barangay Council of Barangay Old Balara has passed Barangay Resolution No. 066, S-98, expressing support to the move for the expropriation of the subject lot for use as public park and playground;


NOW, THEREFORE,

Mathay, Jr., to acquire, through negotiation or expropriation, a six hundred square-meter lot located at Villa Beatriz, Barangay Old Balara, Quezon City, for restoration as site of a public park and basketball court.
