A RESOLUTION URGING THE HONORABLE CITY MAYOR, ISMAEL A. MATHAY, JR., TO ESTABLISH A 24-HOUR LYING-IN FACILITY AT LA LOMA HEALTH CENTER LOCATED AT MARIVELES STREET, BARANGAY PAANG BUNDOK, DISTRICT I, QUEZON CITY, TO AUGMENT THE HEALTH SERVICES PRESENTLY OFFERED BY THE CENTER.

WHEREAS, the present services available at La Loma Health Center do not include lying-in facility which is a necessity in order for the center to provide comprehensive medical services to the residents of Barangay Paang Bundok and nearby barangays;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor, Ismael A. Mathay, Jr., to establish a 24-hour lying-in facility at La Loma Health Center located at Mariveles Street, Barangay Paang Bundok, District I, Quezon City, to augment the health services presently offered by the Center.

RESOLVED, FINALLY, that the City Health Officer shall detail or assign personnel to man and operate the lying-in clinic or section until such time that appropriate permanent regular plantilla positions shall have been created for the purpose.
