RESOLUTION NO. SP. 1107, S-99

A RESOLUTION AUTHORIZING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, TO SELL TO MR. PATRICIO L. DURLAO, FORMER CHIEF OF THE BUSINESS PERMITS AND LICENSING OFFICE, THE MOTOR VEHICLE ASSIGNED TO HIM AS DEPARTMENT HEAD, A TOYOTA COROLLA, 4-DOOR SEDAN, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, Quezon City Council Resolution No. 8630, Series of 1971, authorizes the sale to incumbent officials, officers and employees of the Quezon City government, the vehicles and other office furnitures presently assigned to them, should they be willing to purchase the same at their appraised value at the time of the sale, provided that taxes payable and due to the government shall be shouldered by the purchaser;

WHEREAS, a certain motor vehicle, particularly described hereunder, was assigned and issued to Mr. Patricio L. Dumlao as Chief of the Quezon City Business Permits and Licensing Office, to wit:
