RESOLUTION NO. SP-1110, S-99

HUNDRED NINETY-SEVEN FOUR ALLOCATING RESOLUTION THOUSAND PESOS (P497,000.00) OR SO MUCH THEREOF TO PROVIDE IMMEDIATE RELIEF ASSISTANCE TO THE VICTIMS OF FIRE CONSISTING OF ONE HUNDRED NINETY (190) HOUSE-OWNERS AND ONE HUNDRED SEVENTEEN (117) HOUSE-RENTERS/SHARERS, AT POOK MASAGANA, MINDANAO AVENUE, BARANGAY BAHAY TORO, DISTRICT I, QUEZON CITY, THE NECESSARY FUNDS THEREFOR TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, a fire occurred at Pook Masagana, Mindanao Avenue, Barangay Bahay Toro, District I, Quezon City, at around 1:00 P.M. last January 23, 1999, affecting One Hundred Ninety (190) house-owners and One Hundred Seventeen (117) house-sharers/renters;

WHEREAS, these unfortunate fire victims need the help and assistance of the City government in the form of material assistance, such as building materials for the reconstruction of their houses, purchase of food, clothing, etc., in the amount of Two Thousand Pesos (P2,000.00) each for house-owners and One Thousand Pesos (P1,000.00) each for house-renters/sharer;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to allocate, as it does hereby allocate, Four Hundred Ninety-Seven Thousand Pesos (P497,000.00) or so much thereof to provide immediate relief assistance to the victims of fire, consisting of One Hundred Ninety (190) house-owners and one hundred seventeen (117) house-renters/sharers, at Pook
