RESOLUTION NO. ~~SP-1111~~, S-99

A RESOLUTION REQUESTING THE CITY GOVERNMENT TO EXTEND FINANCIAL ASSISTANCE TO THE FIFTY SEVEN (57) FAMILIES WHO WERE RENDERED HOMELESS BY A FIRE AT NO. 13 MANUNGGAL STREET, BARANGAY TATALON, DISTRICT IV, QUEZON CITY, IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER AND ALLOCATING THE SUM OF NINETY ONE THOUSAND PESOS (P91,000.00) TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, Section 458 (a) (l) (iv) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

“Sec. 458. (a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this code, shall:

- (l) Approve ordinances and pass resolutions necessary for an efficient and effective city government and in this connection, shall:
 - (iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disaster or calamities and in their return to productive livelihood following said events.

WHEREAS, on October 28, 1998, some fifty-seven (57) families were rendered homeless by an unfriendly fire at No. 13 Manunggal Street, Barangay Tatalon, District IV, Quezon City, as per census conducted by the Social Services Development Department (SSDD), categorized as follows:

FAMILY OWNER:	thirty-four	34

TOTAL	fifty seven	57

WHEREAS, because of this unfortunate incident, our constituents will need the help and assistance of the city government in the form of financial aid for the purchase of food, clothing and materials for the construction of their houses;

WHEREAS, these unfortunate family victims, who are presently in makeshift houses can only hope and pray for the early release of financial assistance from the City government;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the City government to extend financial assistance to the fifty seven (57) families who were rendered homeless by a fire at 13 Manunggal Street, Barangay Tatalon, District IV, Quezon City, in the amount of two thousand pesos (P2,000.00) per family owner and one thousand pesos (P1,000.00) per family renter/sharer and allocating the sum of ninety one thousand pesos (P91,000.00) to be taken from the calamity or emergency fund or from any available funds of the City.


RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate and authenticate the list of fire victims categorized into family owner, family sharer and family renter and to submit the same to the Office of the City Mayor, likewise making representation for the early release of the financial assistance to the qualified recipients.

RESOLVED, FINALLY, that the Office of the City Mayor shall revalidate and confirm the list submitted by the Social Services Development Department which will be the basis for the preparation of the payroll and immediate approval for the release of funds allocated for the purpose.
