## RESOLUTION NO. SP-1117 -\$-99

A RESOLUTION AUTHORIZING HIS HONOR, MAYOR ISMAEL A. MATHAY JR., TO ACCEPT THE COMPLETED INFRASTRUCTURE PROJECT FOR TATALON ESTATE AND THAT PARCEL OF LAND PARTICULARLY DESCRIBED AS BLOCK 9, BCS-3169 LOCATED ALONG G. ARANETA AVENUE NEAR MATALAHIB CREEK, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 37216, AND REGISTERED IN THE NAME OF THE NATIONAL HOUSING AUTHORITY CONTAINING, MORE OR LESS, ONE THOUSAND THREE HUNDRED TWELVE SQUARE METERS (1,312 SQ.M.) TO BE TURNED-OVER BY THE NATIONAL HOUSING AUTHORITY OF WHICH PORTION OF THE SAID LOT CONTAINING SEVEN HUNDRED FORTY (740) SQUARE METERS WILL BE USED AS THE SITE OF THE MULTI-PURPOSE HALL OF BARANGAY STO DOMINGO, QUEZON CITY.

WHEREAS, there is a parcel of land located along G. Araneta Avenue near Matalahib Creek, Barangay Sto. Domingo, Quezon City, owned by the National Housing Authority containing, more or less, One Thousand Three Hundred Twelve Square Meters (1,312 sq.m.) with Transfer Certificate of Title No. 37216;

WHEREAS, the National Housing Authority had initiated development on the said parcel of land known as Tatalon Estate Infrastructure Project and the same has been completed;

WHEREAS, the Sanggunian Barangay of Barangay Sto. Domingo, Quezon City, through the Punong Barangay, Honorable Jose Valdez had requested the National Housing Authority to utilize the open space containing, more or less, Seven Hundred Forty square meters as a site of the Barangay Multi-Purpose Hall;

WHEREAS, the National Housing Authority, through its governing Board, signified its conformity and, thus interposes no objection to the said request provided the Quezon City government, through the City Mayor, accepts the completed Tatalon Estate Infrastructure Project as authorized by a Quezon City Council Resolution;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" provides that the City Mayor, as the Chief Executive of the City government is empowered to represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, there is a need to pass a measure for the acceptance of the said infrastructure project to pave the way for the construction of the Multi-Purpose Hall of Barangay Sto. Domingo;

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Mayor Ismael A. Mathay Jr., to accept the completed infrastructure project for Tatalon Estate and that parcel of land particularly described as Block 9, BCS-3169 located along Araneta Avenue near Matalahib Creek, covered by Transfer Certificate of Title No. 37216 and registered in the name of National Housing Authority containing, more or less, One Thousand Three Hundred Twelve square meters (1,312 sq.m.) to be turned-over by the National Housing Authority of which a portion of the said lot containing Seven Hundred Forty (740) square meters will be used as the site of the multi-purpose hall of Barangay Sto Domingo, Quezon City
