A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO DISPOSE OF THE PARCELS OF LAND (PETINES COMPOUND/RELOCATION SITE) LOCATED AT BARANGAY BAGONG SILANGAN IN FAVOR OF THE QUALIFIED AND ACTUAL OCCUPANTS/RELOCATEES AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE.

WHEREAS, the Quezon City government is the owner of parcels of land (Petines Compound) situated in Barangay Bagong Silangan, with an aggregate area of Twenty Three Thousand Seven Hundred Ten (23,710) square meters, evidenced by TCT Nos. 57470 and 57469;

WHEREAS, the said parcels of land are now the relocation site of the city government;

WHEREAS, the present City dispensation is cognizant of extending the full amenities of the family of a progressive community to relocation areas of the city like the Petines Compound Barangay Bagong Silangan;

WHEREAS, the development of Petines Compound will enhance the quality of life of the family of residents thereat through the implementation of site and improvements, installation of needed amenities, and the eventual turn-over of the land ownership to the actual occupants;


WHEREAS, the qualified beneficiaries of the relocation program at the Petines Compound are now petitioning the City government to allow them to acquire thru purchase of the lot they are actually occupying in accordance with the manner prescribed by existing laws;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, City Mayor, Honorable Ismael A. Mathay, Jr., to dispose of the parcels of land (Petines Compound/relocation site) located at Barangay Bagong Silangan in favor of the

qualified and actual occupants/relocatees at a price to be determined by the City Appraisal Committee.
