RESOLUTION NO. ~~SP-1128~~ S-99

A RESOLUTION AMENDING RESOLUTION NO. SP-24, S-92, PROVIDING FOR THE MEMBERSHIP OF THE PERSONNEL SELECTION BOARD OF THE QUEZON CITY GOVERNMENT, SO AS TO INCLUDE THE PRESIDENT OR THE DESIGNATED REPRESENTATIVE OF THE DULY REGISTERED AND ACCREDITED QUEZON CITY HALL EMPLOYEES ASSOCIATION

Introduced by Councilors JESUS C. SUNTAY, ERIC Z. MEDINA,
WINSTON "Winnie" T. CASTELO and GODOFREDO T. LIBAN II.

WHEREAS, Section 80 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that:

- a) x x x...
- b) There shall be established in every province, city or municipality a Personnel Selection Board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare;
- c) The personnel selection board shall be headed by the local chief executive and its members shall be determined by resolution of the sanggunian concerned. A representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned shall be ex-officio members of the board.

WHEREAS, Resolution No. SP 24, S-92, provides for the membership of the Personnel Selection Board of the Quezon City government, as follows;

- a) Majority Floor Leader, or the duly designated member of the Majority Party;
- b) Minority Floor Leader, or duly designated member of the Minority Party;
- c) Department Head concerned whose office is involved or the subject of selection/evaluation of personnel;

WHEREAS, the present membership of the Personnel Selection Board does not include a representative of the Quezon City Hall employees, thereby depriving the employees of proper representation in the said Board;

WHEREAS, it is for the best interest of the employees of Quezon City Hall to have a representative in the Personnel Selection Board to ensure judicious and objective selection of personnel for employment as well as for promotion;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-24, S-92, providing for the membership of the Personnel Selection Board of the Quezon City government so as to include the President or the designated representative of the duly registered and accredited Quezon City Hall employees association, as follows:

“BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to provide, as it does hereby provide, for the following members of the Personnel Selection Board of the Quezon City government in addition to the members provided for under Section 80 of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”:


- a. Majority Floor Leader or, the duly designated member of the Majority Party.
- b. Minority Floor Leader or, the duly designated member of the Minority Party.
- c. Department Head concerned whose office is involved or the subject of selection/evaluation of personnel.
- d. President or the designated representative of the duly registered and accredited Quezon City Hall employees association.”

RESOLVED, FURTHER, in case there are two (2) or more registered and accredited employees association, the President or the duly designated representative of the association that won in a Certification Election pursuant to Executive Order No. 180, Series of 1987 and its Implementing Rules and Regulations, shall sit as member of the Personnel Selection Board.
