A RESOLUTION URGENTLY REQUESTING PRIORITY IN THE ON-GOING PROJECT OF THE TRAFFIC ENGINEERING CENTER FOR THE INSTALLATION OF TRAFFIC LIGHTS AT WEST AVENUE CORNER BALER, BALER CORNER ROOSEVELT, WEST AVENUE CORNER EXAMINER STREET, SAN JOSE CORNER BONIFACIO STREET, MARIA CLARA AND AMORANTO STREET CORNER ARANETA AVENUE, BALINGASA CORNER BONIFACIO STREET, CORUMI STREET CORNER DEL MONTE AVENUE, CORNER TANDANG SORA AND MALAC STREET CORNER DEL MONTE AVENUE, ALL IN QUEZON CITY,

WHEREAS, the areas described above are most often than not heavily congested at all hours of the day;

WHEREAS, these areas are also often neglected by Traffic Enforcers which causes delays and inconvenience to motorists using these streets;

WHEREAS, the only possible way to avoid these problems is to install traffic lights in the vicinity;

WHEREAS, the Traffic Engineering Center is now in the process of installing traffic lights at unlighted portion of the City of Manila;

WHEREAS, Quezon City, being one of the prime cities of Metro Manila, should have priority in the installation of street lights.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby urgently request, priority in the on-going project of the Traffic Engineering Center for the installation of traffic lights at West Avenue corner Baler, Baler corner Roosevelt, West Avenue corner Examiner


