A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY JR., AS THE FIRST PARTY AND ANGELOT CONSTRUCTION & GENERAL MERCHANDISE, REPRESENTED BY ITS MANAGER, ANGELITA K. BARRIENTOS, AS THE SECOND PARTY, FOR THE RENOVATION OF THE CITY HEALTH DEPARTMENT AND PHARMACY OFFICE LOCATED AT THE GROUND FLOOR OF THE QUEZON CITY HALL, IN THE AMOUNT OF FIVE HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED TWENTY-FOUR PESOS AND SIXTY-TWO CENTAVOS (P587,424.62), SUBJECT TO EXISTING LAWS, RULES AND INTERNAL GOVERNMENT.

WHEREAS, after proper negotiations, the Quezon City government, represented by Mayor Ismael A. Mathay Jr., executed a contract with Angelot Construction & General Merchandise, represented by its manager, Angelita K. Barrientos, for the proposed repair and improvement of City Health Department & Pharmacy Office, Quezon City, in the amount of Five Hundred Eighty Seven Thousand Four Hundred Twenty-Four Pesos and Sixty-Two Centavos (P587,424.62), as evidenced by a copy of said Contract hereto attached as Annex "A" and forming an integral part hereof,

WHEREAS, the said Contract (Annex "A") is valid and legal in all respects and may be ratified by the City Council;


