A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE PO3 ARNOLD SALCEDO REYES, A MEMBER OF THE PHILIPPINE NATIONAL POLICE (CENTRAL POLICE DISTRICT COMMAND), WHO WAS SHOT AND STABBED TO DEATH BY STILL UNIDENTIFIED ARMED PERSONS ON JUNE 28, 1993, THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 1999 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR, OR FROM FUNDS AVAILABLE FOR THE PURPOSE.

WHEREAS, the untimely death of PO3 Arnold Salcedo Reyes, member of the Central Police District Command (CPDC) assigned at the General Services, North CAPCOM, this City, is a loss to the CPDC and to his bereaved family;

WHEREAS, almost all the life savings of PO3 Reyes have gone to the funeral services alone and the family now faces a very bleak future;

WHEREAS, we, at the City government should manifest to all that we know how to care for the bereaved families of those who have sworn to protect the lives, limbs and properties of our people, and one tangible manner at least is by substantial financial assistance;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the family of the late PO3 Arnold Salcedo Reyes, a member of the Philippine National Police (Central Police District Command), who was shot and stabbed to death by still unidentified armed persons on June 28, 1993, the amount to be charged against the appropriation for Grants, Subsidies and Contributions in the 1999 Annual Budget of the Office of the City Mayor, or from funds available for the purpose.
