# RESOLUTION NO. SP. 1142 - S-99

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO INFOCOM COMMUNICATIONS NETWORK, INC., FOR THE CONSTRUCTION/ERECTION OF A TELECOMMUNICATION TOWER LOCATED AT NO. 315 COMMONWEALTH AVENUE, DILIMAN, QUEZON CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-176147 OF THE REGISTRY OF DEEDS OF QUEZON CITY.

## Introduced by Councilor MICHAEL F. PLANAS

WHEREAS, petitioner Infocom Communications Network, Inc., is an operator of a telecommunication services network;

WHEREAS, petitioner Infocom Communications Network, Inc., is embarking on an expansion program of its telecommunication network facilities particularly in Quezon City, and has identified an area therein where its telecommunication tower will be located;

WHEREAS, petitioner Infocom Communication Network, Inc., has applied with the Quezon City Council for the issuance of a Special Use Permit as required in Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992" and its Implementing Rules and Regulations;

WHEREAS, it is to the public interest that the improvement, modernization and expansion of telecommunication facilities, particularly in Quezon City, are encouraged and expedited;

### NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Infocom Communications Network Inc., for the construction/erection of a telecommunication tower located at No. 315 Commonwealth Avenue, Diliman, Quezon City, covered by Transfer Certificate of Title Numbered N-176147 of the Registry of Deeds of Quezon City; PROVIDED, HOWEVER, that Infocom Communications Network Inc., shall bear the exclusive responsibility for the sound maintenance of such facilities;
