WHEREAS, Senator Blas F. Ople, Senator Gregorio B. Honasan and House Representative Raul M. Gonzales have filed Senate Bill No. 494, Senate Bill No. 1224 and House Bill No. 81, respectively, seeking to grant the disabled persons the same privileges enjoyed by senior citizens;

WHEREAS, the discount privileges granted to Persons with Disabilities (PWDs) are not sufficiently and clearly provided in R.A. 7277 known as the Magna Carta for Disabled Persons resulting to discontentment and dissatisfaction among the people who should enjoy the benefits provided by law;

WHEREAS, there is a need for the speedy passage of the abovesited proposed bills to boost the morale of the PWDs and help lessen the financial burdens being experienced by their respective families;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Senate and the House of Representatives to pass immediately Senate Bills Numbered 494 and 1224, and House Bill No. 811, granting disabled persons the same privileges and incentives enjoyed by Senior Citizens.
