A RESOLUTION RATIFYING THE CONTRACT OF SALE ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT AND MS. CONSTANCIA DAYLO ON FEBRUARY 11, 1987, INVOLVING THE SALE OF A PARCEL OF LAND LOCATED ALONG CULIAT CREEK, BAGO BANTAY, QUEZON CITY, PARTICULARLY LOT 2, BLOCK 55, PSD-13-001644 OF THE SUBDIVISION PLAN APPROVED ON FEBRUARY 12, 1986, CONTAINING AN AREA OF TWO HUNDRED THIRTY FOUR SQUARE METERS AND SEVENTY NINE SQUARE DECIMETERS (234.79) AND DIRECTING THE CITY LEGAL OFFICER TO PREPARE THE DEED OF ABSOLUTE SALE UPON FULL PAYMENT OF THE CONSIDERATION THEREOF.

WHEREAS, Ms. Constancia Daylo was one of the awardees whose Contract of Sale was approved by the Office of the President on May 8, 1987, upon the recommendation of the Commission on Audit, subject, however, to the usual audit and compliance with the terms and conditions thereof;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract of Sale entered into by and between the Quezon City government and Ms. Constancia Daylo on February 11, 1987, involving the sale of a parcel of land located along Culiati Creek, Bago Bantay, Quezon City, particularly Lot 2, Block 55, Psd-13-001644 of the subdivision plan approved on February 12, 1986, containing an area of Two Hundred Thirty-Four Square Meters and Seventy Nine Square Decimeters (234.79).

RESOLVED, FURTHER, that the City Legal Officer be directed to prepare the Deed of Absolute Sale upon full payment of the consideration thereof for the signature of the City Mayor representing the Quezon City government and the surviving legal heirs representing the deceased awardee, Ms. Constancia Daylo.
