RESOLUTION NO. SP-1 168 , S-99

A RESOLUTION URGING THE HONORABLE ISMAEL A. MATHAY, JR. CITY MAYOR, TO CREATE A COMMITTEE FOR THE PURPOSE OF UNDERTAKING A CAREFUL STUDY AND FORMULATE EFFECTIVE PLANS AND PROGRAMS IN CONNECTION WITH THE CLOSURE OF THE PAYATAS DUMPSITE AS PER THE EXECUTIVE ORDER OF HIS EXCELLENCY, THE PRESIDENT OF THE PHILIPPINES, AND THE ESTABLISHMENT OF WASTE MANAGEMENT FACILITY IN THE AREA FOR THE CITY'S WASTE MATERIALS.

WHEREAS, the Office of the President of the Republic of the Philippines has ordered the closure of the Payatas dumpsite in the earliest possible time and the establishment of a waste management facility in the areas;

WHEREA'S, while it is true that the Office of the President has created its own task force for this purpose, it is imperative for the Quezon City government to conduct its own study and recommendation for implementation of the procedures of the closure because of its total awareness of the issues involved, hence it can respond more effectively to the situation;

WHEREAS, due to the length of time that the dumpsite has been operational and considering the situation not only inside the dumpsite but also the surrounding areas, it is but necessary that the City ensure and guarantee the smooth relocation of the residents and effect a failsafe community development program in the area;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Hon. Ismael A. Mathay, Jr., City Mayor, to create a committee for the purpose of undertaking a careful study and formulate effective plans and programs in connection with the closure of the Payatas dumpsite as per the executive order of His Excellency, the President of the Philippines, and the establishment of waste management facility in the area for the City's waste materials.
