A RESOLUTION STRONGLY URGING THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA) TO EXEMPT THE LOYOLA HEIGHTS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION AND THE LOYOLA-PANSOL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION FROM THE IMPLEMENTATION OF METRO MANILA COUNCIL ORDINANCE NO. 6, S-90 (MMDA) ALONG THE STRETCH OF KATIPUNAN ROAD BETWEEN AURORA BOULEVARD AND PANSOL ROAD.

WHEREAS, Metro Manila Council Ordinance No. 6, S-90 prohibits pedicabs and tricycles from operating along highways and major thoroughfares within Metro Manila and limiting their operations to tertiary roads and within subdivisions;

WHEREAS, the strict implementation of Metro Manila Ordinance No. 6, S-90 has adversely affected the Loyola Heights Tricycle Operators and Drivers Association and the Loyola-Pansol Tricycle Operators and Drivers Association which includes in its main route traversing through Katipunan Road which is a major thoroughfare;

WHEREAS, the prohibition against tricycles to pass through Katipunan Road has resulted in untold hardships and inconvenience to the commuting public and has adversely affected the source of livelihood of the members of the Loyola Heights Tricycle Operators and Drivers Association and the Loyola-Pansol Tricycle Operators and Drivers Association;

WHEREAS, Sec. 5 of Metro Manila Council Ordinance No. 6, S-90, provides for an exemption from the implementation of the ordinance, to wit:

"Any exemption in the implementation of this Ordinance shall be covered by the corresponding Municipal/City Council Resolution and duly approved by the Metro Manila Council, Metro Manila Development Authority;"

WHEREAS, with the support of the Sangguniang Barangay of Loyola Heights, the Loyola Heights Tricycle Operators and Drivers Association and Loyola-Pansol Tricycle Operators and Drivers Association are invoking the City Council's assistance in seeking an exemption from the provisions of Metro Manila Council Ordinance No. 6, S-90 (MMDA);

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Metro Manila Development Authority (MMDA) to exempt the Loyola Heights Tricycle Operators and Drivers Association and the Loyola-Pansol Tricycle Operators and Drivers Association from the implementation of Metro Manila Council Ordinance No. 6, S-90 (MMDA) along the stretch of Katipunan Road between Aurora Boulevard and Pansol Road.
