RESOLUTION NO. SP-1175-, S-99

A RESOLUTION URGING THE NATIONAL HOME MORTGAGE FINANCE CORPORATION OR PAG-IBIG TO INCREASE ITS LOANABLE AMOUNT FOR SOCIALIZED HOUSING PROJECT FROM SIXTY THOUSAND PESOS (P60,000.00) TO ONE HUNDRED THOUSAND PESOS (P100,000.00).

WHEREAS, the Community Mortgage Program currently administered by the National Home Mortgage Finance Corporation is an innovative concept of low-income financing whereby an undivided tract of land may be acquired by several beneficiaries through community ownership;

WHEREAS, the program seeks to secure land tenure for the landless urban poor and has made a significant contribution and valuable support to the government's shelter program;

WHEREAS, the present loanable amount of an individual beneficiary with a formal and informal income is Sixty Thousand Pesos (P60,000.00);

WHEREAS, due to the present economic crisis and the peso devaluation, the amount of Sixty Thousand Pesos (P60,000.00) loanable for each beneficiary is not anymore sufficient to meet the standard set forth in order to assist landless communities in sustaining the shelter program;

WHEREAS, the proposed One Hundred Thousand Pesos (P100,000.00) loanable amount will be more than enough for a positive result that will ensure decent shelter for the marginalized society as they will be able to cope with their new responsibilities as lot owners;
