WHEREAS, the National Power Corporation (NPC) owns the land located at Insurance Street, GSIS Village, Barangay Sangandaan, Quezon City;

WHEREAS, the afore-mentioned parcel of land have been occupied openly and continuously for more than twenty (20) years by about three hundred (300) families who have organized themselves into Samahan ng mga Ginang, Inc;

WHEREAS, the actual occupants are now soliciting the assistance of the City government and the Honorable City Council to urge and convince the National Power Corporation (NPC) to implement the "on-site development program" in the disposition of the NPC land as an initial step in their quest for a decent shelter;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the National Power Corporation to implement the "on-site development program" in the disposition of its property located at the Napocor Transmission Lines, 72 Insurance St., Barangay Sangandaan, Quezon City, to the actual bonafide occupants thereof.
