RESOLUTION ALLOCATING THE SUM OF FIFTY THOUSAND PESOS (P50,000.00) FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OR FROM AVAILABLE FUND OF THE EXECUTIVE DEPARTMENT AS FINANCIAL ASSISTANCE TO MR. ALMARIO MARLON Q. BERNARDINO, JR. WHO WILL REPRESENT THE COUNTRY IN THE 1999 WORLD OPEN TO BE HELD IN PHILADELPHIA, PENNSYLVANIA, U.S. A., ON JUNE 27 TO JULY 5, 1999.

WHEREAS, the Continental Chess Association invited Mr. Bernardino to participate in the 1999 World Open to be held at the Adam's Mark Hotel in Philadelphia, Pennsylvania, U.S.A., on June 27 to July 5, 1999, thereby giving him the opportunity to earn Fide Master title or at least an International Master Norm;

WHEREAS, considering the significance of his participation, it is necessary that financial assistance be extended to Mr. Bernardino to help him defray his travel and tournament expenses as ambassador of goodwill not only of Quezon City, but of the Philippines, as well; Quelogo
