RESOLUTION NO. SP-1201 , 3-99

A RESOLUTION URGING THE PHILIPPINE NATIONAL POLICE SECURITY AGENCIES GUARDS SUPERVISION DIVISION (SAGSD) TO FULLY AND STRICTLY IMPLEMENT THE DRUG TEST POLICY ON ALL SECURITY GUARDS POSTED IN THE JURISDICTION OF QUEZON CITY AT THE EXPENSE OF THE SECURITY AGENCY CONCERNED.

WHEREAS, the Sangguniang Panlungsod is empowered to approve resolution for the general welfare of the City and its inhabitants pursuant to Section 16 of the Local Government Code;

WHEREAS, on several occassions security guards posted in Quezon City are arrogant and sometimes, in connivance with robbers, robbed their client bank and worst still, in overdoing their task, have committed homicide in screening bank depositors, or clients;

WHEREAS, the reason for the foregoing is due to laxity in conducting drug test on security guards;

WHEREAS, in order to avoid future similar incidents it is imperative that full implementation and strict compliance with the drug test policy on all security guards posted in Quezon City be undertaken at the expense of the Security Agency;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Philippine National Police Security Agencies Guards Supervision Division (SAGSD) to fully and strictly implement the drug test policy on all security guards posted in the jurisdiction of Quezon City at the expense of the security agency concerned.
