A RESOLUTION STRONGLY URGING THE EXECUTIVE DEPARTMENT OF THE QUEZON CITY GOVERNMENT TO STRICTLY IMPLEMENT QUEZON CITY ORDINANCE NO. NC-246, S-91, TO CURTAIL THE UNSCRUPULOUS PRACTICE OF FUNERAL PARLORS VICTIMIZING THE URBAN POOR OF QUEZON CITY.

WHEREAS, it has been the perennial problem and common practice of most of the funeral parlors in Quezon City to take and embalm the cadaver of the deceased person without the knowledge and consent of the bereaved family;

WHEREAS, the unscrupulous funeral parlors often victimize the family of the deceased by taking advantage of the traumatic experience and agony by offering its services beyond the paying capacity of the bereaved family;

WHEREAS, despite of Quezon City Ordinance No. NC-246, S-91 penalizing funeral parlor owners, operators and personnel for not informing the bereaved family without prior notification of the price of the casket to be used, most funeral parlors totally neglect to comply with the said Ordinances;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Executive Department of the Quezon City government to strictly implement Quezon City Ordinance No. NC-246, S-91, to curtail the unscrupulous practice of funeral parlors victimizing the urban poor of Quezon City.
